## **STATEMENT**

- 4) I meet the independence criteria for a candidate for a supervisory board member specified by European Commission in Annex II to the Commission Recommendation of 15 February 2005 on the role of non-executive or supervisory directors of listed companies and on the committees of the (supervisory) board (OJ EU L 05.52.51), Article 129 of the Act of 11 May 2017 on statutory auditors, audit firms and public supervision (consolidated text, Journal of Laws of 2020, item 1415 of 19 August 2020), as well as additional requirements specified in Good Practice of Companies Listed on the WSE, which is attached to Resolution No 27/1414/2015 of the WSE Supervisory Board of 13 October 2015;
- 5) I do not perform the functions or hold the offices specified in Articles 1-2 of the Act of 21 August 1997 on the limitation of economic activity by persons performing public functions (consolidated text, Journal of Laws of 2019, item 2399 of 13 December 2019);
- 6) I consent to the processing and publication of my personal data within the meaning of the Act of 10 May 2018 on the protection of personal data (consolidated text, Journal of Laws of 2019, item 1781 of 19 September 2019), as well as any data contained in the Curriculum Vitae provided to the Company, to the extent required in relation to the candidacy for and membership in the Company's Supervisory Board.
